For orders placed in advance of the move in of the show, the CCTV system rented will be set the day prior to the event, at which time the recording will begin, recording will stop when the unit is removed from the booth on the evening the event closes. Additional cameras are also available as rentals, but please keep in mind an additional DVR will be needed for every 8 cameras. Orders placed less than 72 hours in advance are not guaranteed.
